Job Description and Responsibility Breakdown

Resource Development and Planning (25%)

- Develop fun, engaging, and culturally responsive activities for youth
- Identify and adapt existing educational resources to ensure cultural relevance
- Contribute to developing systems and procedures for program structure (e.g. behavioral agreements, a youth-friendly land and ancestral acknowledgment)
- Improve programs and activities based on youth and guardian feedback
- Work with partners to co-design programs based on community need
- Scout locations for potential and existing programs to assess risk and ensure accessibility

Direct Programming Implementation and Assessment (50%)

- Facilitate day [up to 16 per year] and overnight trips [up to 4 per year]
- Facilitate educational lessons with community partners, including schools
- Model respect and consideration for the natural world to youth participants
- Provide opportunities for youth to verbally process their experience without shame or judgment
- Build healthy and trusting relationships with youth rooted in mutual respect
- Set and hold boundaries with youth, enforcing previously agreed upon consequences when necessary
- Manage event registrations (e.g. release from liability, photo release, participant communication, dietary restrictions, etc.)
- Recruit program participants by strategically advertising upcoming programs
- Support, manage and vet volunteers
- Create and disseminate program evaluations
- Process and communicate data from evaluations
- Complete program reports, including grant reporting

Community Communications and Engagement (15%)

- Represent Braided Seeds at community tabling events
- Develop and maintain critical relationships with community partners
- Strategically post youth program updates on social media to encourage youth engagement

Professional and Organizational Development (10%)

- Participate in YPQI training and paid professional development
- Attend trainings, workshops, and staff meetings
- Participate as a representative of Braided Seeds in professional learning communities
